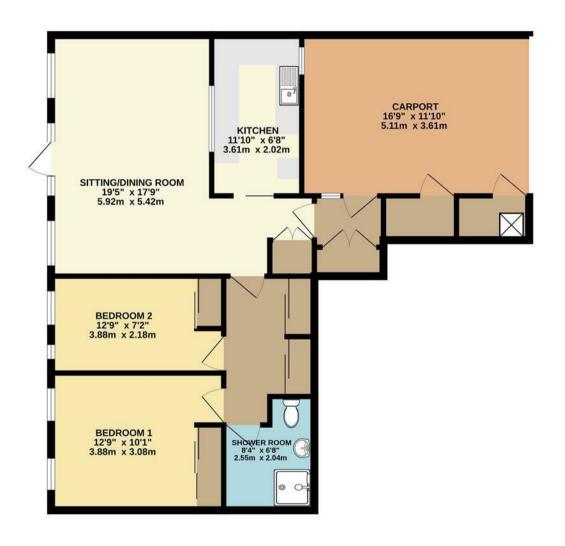

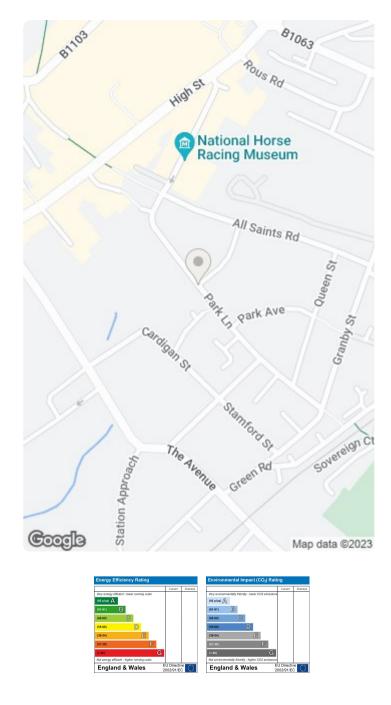






## GROUND FLOOR 933 sq.ft. (86.7 sq.m.) approx.
